Heed all Indexes! - Symbols and #'s must be followed !

- + VW / Audi quick fit belt can be installed without vehicle alteration.
- S Stock seat not approved. For installation of tail strap to this anchor point, use only special seats, tested and approved by SCHROTH.
For SCHROTH tested and approved special seats see list below.

10) Index "S" do not refer to vehicles equipped with RECARO front seats ("sport seats").

27) To avoid release of the pyrotechnic seat pretensioning devices the battery has to be disconnected 10 minutes before starting installation.

35) If stock 3-point belt should be removed from the car never remove stock seat belt buckle as there is a safety device included (VW-description: lunar module) which never must be removed from the car.
